Respected Sir ,


We would like to draw your kind notice that the BSNL CO letter under reference 1 has forwarded association letters to the DDG (Est) DoT. However, it has inadvertently limited the scope of the issue to seeking a Presidential Order only for the officials sent for training by DOT before BSNL's formation, with regard to the extension of CCS pension benefits.

In our letter cited under ref 2, we very specifically requested that the recent GOI (DOP&PW) OM extending the CCS pension benefits shall be made applicable to the TTA officials appointed in BSNL, whose recruitment was made through the DOT Notification/vacancies before 1.10.2000. It is, therefore, reverentially requested to cause the inclusion of all the TTAs recruited through DOT Notification and rectify the subject of the forwarding letter; otherwise, it will completely mislead the DOT/DOPT for further proceedings to extend the CCS pension benefits to rightfully eligible employees.

In light of the above, we fervently appeal for your kind intervention to urgently address this matter and take the necessary steps to rectify the oversight. We seek justice for this dedicated group of TTA officials recruited through DOT notifications before the formation of BSNL.
