Subject: Conducting CPCs for filling-up of the vacant SDEs/DEs/AGMs/AOs/CAOs/EE(C) posts on Adhoc basis subject to outcome of court cases – Our requests regarding.

Respected Sir,

It is in continuation to our earlier communication dated 12.05.2016, 30.05.2016, 19.11.2016, and 05.12.2017 wherein we are continuously pursuing and requested to fill-up about 10,000 posts of SDEs (T), 3,000 posts of DETs/AGMs(T), 1,000 posts of AOs and about 900 posts of Chief Accounts Officers at the earliest. These CPCs have been stalled due to an Interim Order issued by Hon'ble CAT, Chandigarh Bench in the OA No. 060/00295/2015 & MA No. 060/01324/15 dated 14.03.2016. It is worthwhile to mention that Hon'ble court has not granted any stay order on the CPCs.


Management after taking the legal advice has impleaded in the SLP pending in the Hon'ble Supreme Court of India in the matter of Laxmi Narain against the judgment of Hon'ble High Court of Punjab & Haryana. Hon'ble Supreme Court is taking its own time in deciding the case.

The fact remains that one JTO (T) recruited in the year 1995 is still waiting for his first promotion even after completion of 22 years of service and SDE (T) promoted in the years 2000 are waiting for their DE promotion even after completion of 17 years of regular service as SDE.

In view of the above, it is requested to kindly take immediate steps to initiate the CPCs as per prevailing rules to fill-up about 10,000 SDEs (T) posts, 3,000 DE (T) posts, 1,000 AOs Posts, 900 CAO posts and 150 EE (Civil) posts on Adhoc basis immediately subject to outcome of the Court cases since as on date there is no stay order on promotions.
