Subject Change of Reporting of East Zone Nodal Centre from West Bengal Telecom

Circle to Kolkata Telecom District. - reg.

## Respected Sir,

Kindly refer to the above cited reference, wherein it was requested by AIBSNLEA to cancel the orders of reporting Structure of East Zone Nodal centre from West Bengal Telecom circle to Kolkata Telecom District issued by the BSNL Corporate Office vide Lr.No.4-2/2014- Restg vol.IV(Pt.) Dated. 25.3.2019.

- 1) But to our dismay, BSNL Corporate Office again issued letter of merger vide No. PGM/ERP-GZB/Merger/6 Dtd. 26.4.2019.based on the minutes of meeting between WBTC & Kolkata Telecom District and letter of West Bengal Telecom. Circle, It is found from the BSNL Corporate letter Dtd. 26.4.2019 that total 42 mergers will be done, out of which 40 SSAs will be merge following the Intra-Circle norms, One Circle viz. T.S.Circle will be merge with West Bengal Circle. But only one SSA i.e.,. EZND of West Bengal Telecom Circle proposed to be merge with other Circle viz. Kolkata Telecom District by following Inter-Circle norms and the date of merger will be implemented w.e.f.01.06.2019. We are not able to understand the reason behind it. Intra-Circle SSA merger may be cost effective, but change of reporting of a SSA from one Circle to other Circle, how will not be cost effective.
- 2) WBTC has very limited number of posts stationed at Kolkata. Presently 110 executives (Engg. & Finance) are working in EZNC. If merger is taken place, all such posts will be lost. Executives working in the Territorial Stations/SSAs in the West Bengal Telecom Circle would have very little

room to come back to Kolkata and vice versa, which will create unnecessary unrest amongst the staff and officers, which may also affect the service in turn.

In view of the above, we would, therefore, request you to kindly intervene in the matter and cause to issue necessary instructions to the Officers concerned to cancel the orders of reporting structure of East Zone Nodal Centre from West Bengal Telecom Circle to Kolkata Telecom District.
