Subject: Revision of ONT Price / charges recoverable from disconnected subscribers.

1. GM (TR), BSNL O/o CGMT Karnataka Telecom Circle may kindly refer to his office letter No. TR(SLR)/Genrl Corr./2020-21/65 dated 15-02-2021 vide which it has been brought to notice that during finalization of accounts of closed FTTH connections, as per BSNL C.O. letter No. 1-1/2017-R&C (CFA) [Circular R&C-CFA No. 100/17-18] dated 11-08-2017, the cost of ONT is being billed as due from customer at Rs. 12000 and Rs. 14500 (including GST) for FTTH ONT Type A & Type B respectively, while the market rate of ONT is approximately Rs. 2000/-. Due to this activity of FTTH ONT cost, there is increase in ABF, outstanding amount and consequently outflow of GST.

2. The issue has been examined and it is decided to limit the cost of ONT to be recovered from customer across all circles as **Rs. 2000/- only.**

3. Further, all pending outstanding cases as on date of approval (16-04-2021) shall also be settled at the revised rate.

4. Above charge (para 2) is exclusive of GST.

5. The circle shall ensure to comply with all regulatory mechanism including on line reporting to TRAI and also update the circle website. Further, circle shall ensure to maintain the TRAI guideline w.r.t. number of plans.

6. These instructions shall be implemented with immediate effect.
