Subject: Promotion and posting of LDCE 2015 Qualified candidates in JTO (T) to SDE (T)-Reg.

Respected Madam,

On the subject cited above, we would like to submit that results of the LDCE for promotion from JTO (T) to SDE (T) has been declared by the BSNL and the court cases on the promotion order are also expected to be cleared soon.

In this regard, it is respectfully submitted that a lot of JTOs, who have qualified the LDCE are posted out of their home states since long time. Similarly, there are a lot of transfer cases under Rule-8 in respect of the JTOs are pending, especially from the JTOs who are serving in the circles like North East, J&K etc. There are some transfer requests also on the spouse ground and on medical exigencies. The much awaited SDE (T) LDCE posting offers them a chance to reach their home after a long time.

It would be beneficial on the part of both BSNL as well as these LDCE passed candidates if they are posted in their willing circles as a goodwill gesture.

We are sure that BSNL Management would consider following points while issuing promotion & posting orders of LDCE passed candidates:

1. Cases where spouse is working in other circle. DOPT vide OM F.NO.28034/9/2009-Estt. (A) Dated 30.09.2009 has issued direction to all ministries of Govt. of India to such effect.
2. Medical ground cases (chronicle diseases), where executive is supporting old age parent.
3. Rule-8 transfer cases, where executives have requested for transfer to another circle. Especially, for the executives posted in hard tenure circles like NE I, NE II and J&K for last 8-9 years.

4. Recently BSNL has called for volunteer for Inter Circle transfer vide letter no 2-16/LDCE/2013-Pers.II. Pt. Dated July 25, 2016. All such request may be considered.
5. Those who have not given any request for transfer to any other circle may kindly be kept in same circle. Candidates, in such cases may be allotted same circle based on their LDCE rank.

Since a lot of vacancies are lying vacant in almost all of the circles, there should be no problem in accommodating all such cases. Therefore, it is humbly requested and expected from your kind benevolence to consider the above mention point while directing to issue promotion & posting order.
