We would like to draw you kind attention on the above cited letter under ref (1) above, wherein Services of suitable officers satisfying the eligibility conditions to fill up some posts of Director/ Jt.CCA/ Director Accounts (Postal) in the various offices of DoT on deputation basis from various organizations including BSNL, has been called for. However, the same has been endorsed by BSNL Corporate Office to its field Units only on 03.10.2019 after a gap of 37 days vide letter under ref (2) above with a due date on 04.10.2019 by offering one day time only. Unfortunately 5th and 6th were Saturday & Sunday followed by 7th & 8th were RH and Closed Holidays.

Sir, many of the BSNL JAG level officers drawing E6 NFSG Scale are eligible and willing to serve on deputation in DoT (our parent Department). As the endorsement given by BSNL Corporate Office after a gap of 37 days and time given to the eligible officers to apply is hardly one day, the eligible willing officers could not apply and the BSNL Field Units may also not be in a position to forward their applications along with 5 years APAR as well as Vigilance Clearance in time.
