**Sub: Conduct of 2nd Membership Verification – preparation of electoral rolls**

Sir,


Please refer to this office letter (A-4 of MV2020) dated 17.06.2020 related to preparation of electoral rolls and indicating the time schedule in Annexure-II for preparation of voters list with different stages for its completion. In this regard, it is reiterated to adhere to the following stages as already intimated:-

- i) **Stage-1** – It is understood that by now the primary data might have been taken from the ERP and processed for its correctness and prepared with inclusions and exclusions by the concerned authority (e.g. GM HR /DGM HR). The R.O. and A.R.O. would monitor the completion of all activities of electoral roll preparation as per the time schedule. The draft electoral rolls shall be displayed by 02.07.2020 and its copy shall be provided to the representatives of the participating Associations at SSA level for submission of their objections, if any, latest by 08.07.2020. In case no communication is received by the stipulated date, it will be presumed that the Associations/individuals do not have any objection on the draft electoral rolls.

For this purpose the Associations will nominate their representatives at every level. It is further informed that the Circle Secretaries will communicate SSA/Unit level representatives to concerned SSA and General Secretary will communicate the Circle representatives to concerned Circle by 29.06.2020.

- ii) **Stage-2** – Modified Electoral roll- The concerned HR section shall prepare modified electoral roll by 10.07.2020 after addressing the objections received from the Associations, if any. The SSAs/Units shall provide a copy of the modified electoral roll to the Associations' representatives and advise them to peruse the electoral roll and inform discrepancy, if any by 17.07.2020.

iii) Stage -3 – Final electoral roll- In case any discrepancy is reported, the same shall be addressed suitably and final Electoral Roll shall be prepared by 24.07.2020 taking care of the transfers ordered and implemented under "exception" category (para 2 of letter A3 of MV2020). The SSAs/Units shall display the final Electoral Roll by 25.07.2020. Circles will communicate a list indicating the final number of voters with SSA-wise break-up to this office. Any objection in voter list from Association or Individuals arising out of foreseeable events shall not be entertained after this stage. The ROs will collect the completion report from AROs in respect of all the three stages and send the compiled report to CRO and SR Cell by 30.07.2020.


