3. As per Hon'ble High Court Bombay order dated 21.06.2011 upheld by Hon'ble Supreme Court in SLP (C) No(s) 35756/2012 (BSNL & Ors. Vs. S. If any left out (due to un-assessed/VC pending/exoneration etc.) officer is promoted after date of issue of main promotion order and his/her name was there in the select panel, the same has been included as per his/her position in original select panel. Similarly, if any CQ candidate left out in main promotion order of LDCE due to VC pending/exoneration etc., his/her name has been placed as per merit in eligible vacancy year in the LDCE examination.
