



As per the latest OM dated 19.11.2009, Pension Contribution is to be paid only on the actual basic pay. This OM dated 19.11.2009 is not implemented by DoT with regard to BSNL employees. As a result, BSNL is paying huge amount in excess as Pension Contribution for the last 11 years.
