**Sub: Request for vacation of the Status Quo case in the Hon'ble CAT
Chandigarh in respect of AO to CAO Promotion- regarding**

Respected Sir,

We would like to draw your kind attention on the above cited subject. The Promotion in the Grade of AO to CAO is held up due to the "Status Quo" case in the Hon'ble CAT Chandigarh since long. BSNL has filed Write Petition in the Hon'ble High Court of Punjab and Haryana Chandigarh challenging the Interim Order passed in OA No 60/1435/2018 titled as Anupam Yadav Vs BSNL. The Hon'ble High Court has delivered the judgment dated 28.01.2020 in the CWP-9614-2019 (O&M) that:

"We deemed it appropriate to dispose of the present WP with the direction to the learned CAT to decide at least the application moved by BSNL for Vacation/Modification of the initial impugned order within 15 days of the next hearing. The learned CAT is also requested to make an Endeavour to dispose of the main OA at the earliest..."

The date of hearing in Hon'ble CAT was fixed on 20.03.2020 but could not heard and postponed to 10.08.2020. The case was listed for hearing on 10.08.2020 but it has been further postponed to **06.11.2020** without giving any relaxation to BSNL on the vacation of "Status Quo" in respect of the promotion case of AO to CAO.


Sir, almost one year has been passed, but no relaxation has been received from Hon'ble CAT Chandigarh even after passing the direction by the Hon'ble HC of Punjab and Haryana in Jan, 2020.

There is acute shortage in the Cadre of CAO (only 56 CAOs are presently working in BSNL) and BSNL is not moving further for promotions from among the eligible AOs due to the "Status Quo" ordered by the Hon'ble CAT Chandigarh.

In view of the foregoing, we would request your good self to kindly intervene in the matter and cause to issue necessary instructions to the officers concerned to file an Urgent Misc. Application in the Hon'ble HC of Punjab and Haryana again to adhere the earlier directions of the High Court for early disposal of the Original Application in the Hon'ble CAT Chandigarh so that all vacant posts of CAO in BSNL can be filled up on priority basis and the young AOs of BSNL may get their due promotion and serve the Company with a better zeal and enthusiasm.
