" i) C/S under R-36 issued on 19-09-2016 is pending.

ii) C/S under R-14 issued on 14-10-08, decided on 25-06-2011 as impose the penalty of Reduction of pay by two stages for a period of one year and during the period of such reduction, he will earn increment of pay. On expiry of such period, the reduction will not have the effect of postponing the future increment of pay. (Currency up to 24-6-12)". The concerned Circle is requested to regulate his provisional pension in accordance with the relevant provisions of CCS (Pension) Rules, 1972, The officer shall be given only provisional pension and the DCRG and CVP in respect of the officer shall be withheld till the conclusion of the vigilance/disciplinary case as per CCS (Pension) Rules, 1972.

Retirement orders are being issued on the basis of Vigilance Clearance received from the CVO, BSNL. However, if any, vigilance/disciplinary case comes to the notice, only provisional pension may be granted to the officer(s) concerned and their DCRG and CVP withheld till the conclusion of the vigilance / disciplinary case(s) as per CCS (Pension) Rules, 1972. Such cases should be brought to the notice of CVO, BSNL, and GM (Pers) BSNL, C.O. New Delhi immediately.


