We would like to draw your kind attention on the above cited subject. We extend our sincere thanks for issuance of the long awaited promotion orders in the cadre of DGM (T). As per the above cited orders, 226 DEs were promoted as DGM on adhoc basis.


In this regard, we wish to bring to your kind notice that vide the above cited orders, most of the officers were posted on promotion to their Home Circles but some were posted to other Circles on need basis. The intention of the Management to fill up the vacancies in the shortage Circles is very much appreciated. We are also much thankful to the BSNL Management for considering some of the representations of the officers for retention in their Home Circle on Compassionate/Medical/Immunity grounds positively.

The remaining officers are to be relieved by the end of Mar-2020 for joining at the new place of posting. But suddenly National lock-down has been announced by the Hon'ble Prime Minister of India due the attack of Covid-19 all over the World and also in our Nation. Hence the promoted officers are not relieved from the concerned Circles and also they are not in a position to move out of their Home Town. In some of the Circles like HP etc., the promoted Officers have been relieved in ERP. It is feared that the present situation may continue further and restoration to normalcy will take pretty long time.

In view of the precarious situation, we would request your good self to kindly consider the cases on Humanitarian grounds and those officers who have not yet joined in the new place of posting may kindly be allowed to join as DGM(T) in their Home Circle and retained in their Home Circle to work for at-least six months.
