As per the decision taken in the meeting of the All Unions and Associations of BSNL (AUAB), held on 06.02.2020, notification is hereby issued for launching agitational programme, demanding immediate settlement of the following demands.


Demands:

- (1) Immediately pay the salaries for the month of December, 2019 and January, 2020. Ensure timely payment of the salary every month.
- (2) Immediately remit the dues already deducted from the salaries of the employees, to the concerned organisations.
- (3) Immediately take steps to launch BSNL's 4G service at the Pan India level. Immediately issue Sovereign Guarantee Bonds for Rs.8500 Crores, as per the financial support approved by the Union cabinet.
- (4) Immediately pay the wage arrears of the contract workers.
- (5) Immediately withdraw the notices issued to some leaders, under FR 17(A). Immediately settle the terminal benefits of Com. Kabeer Das, Ex. General Secretary, BSNL OA.
- (6) Do not issue whimsical transfer orders to employees due to the implementation of VRS.

Agitational Programme:


- (1) Lunch hour demonstrations at all levels on 11.02.2020.
- (2) Hunger strike at all levels on 24.02.2020.


