Sir, it is constrained to bring to your kind notice that JTOs in Civil/ Electrical/ TF/Architectural Wings are waiting for their first promotion for more than 20 years, in Telecom Engineering Wing also, JTOs are waiting for more than 19 years for their first promotion, SDEs/AOs are waiting for their DE/CAO promotion for more than 11 years, SDE(C/E/TF/A) are waiting for their promotions to AGM/EE(C/E/TF/A) for more than

20 years, AMs/Assistants from CSS cadre are waiting for their promotions for more than 8 years, and PA/PS/Sr.PS are waiting for their promotion for more than 8 to 10 years.
