Sub: --Seniority list of 147+ (150) LDCE executives of TES Gr.B equivalent to SDE(T) –
revision thereof.

Ref: - The seniority list of 147+ LDCE executives circulated vide this office Letter No.
15-8/2006-Pers-II dt. 11th August, 2008

A combined qualifying-cum- competitive exam was conducted in the year 2000 & 2003 for vacancy year 1994-95 to 1996-97(Upto 22.7.1996) as per RR 1981 and subsequent modification thereof, under 1/3 quota for promotion from JTO to SDE(T) grade. Approximately 150 executives (commonly known as 147 group) were declared passed in the said examination & accordingly, they were promoted to SDE(T) grade in 2005 onwards on different dates, under 1/3rd Quota. However, the seniority and subsequent Promotion granted to these LDCE executives were challenged in various courts.

2. Now, court cases on above seniority and promotions has **attained legal finality** having regard to the decision of Hon'ble Apex Court in the aforementioned CA No. 392/2017 vide Judgement dated 12.12.17. In its Judgment, Hon'ble Supreme Court has upheld the Judgment dtd. 01-07-2013 pronounced by Hon'ble High Court, Kerala in WP (C) No. 5406 of 2010. As per Judgment of Hon'ble Kerala High Court, a candidate should complete 5 years of regular Service in feeder Cadre (JTO) as on 1st January of a Vacancy Year for making him/her eligible.

3. The said Judgment of Hon'ble High Court order dated 01.07.2013 in WP (C) No. 5406/2010 involves 138 BSNL LDCE executives out of total 150, as 12 executives belong to MTNL and hence they have not been included in this List. Out of these 138 BSNL executives, **42** executives mentioned in the **Annexure - I** have been held as eligible & **96** executives mentioned in **Annexure - II** held as ineligible against vacancy years 1994-95 to 1996-97 (part) as brought out in the Judgment of Hon'ble High Court, Kerala.

4. Hence, in accordance with the said judgment, the seniority list circulated vide this office Letter No. 15-8/2006-Pers.II dated 11th August, 2008(Annexure-A7 in OA No.86/09 of Hon'ble CAT Ernakulam) **is cancelled** and fresh revised Seniority list of only 42 BSNL LDCE executives out of total 150 executives of TES Gr. B equivalent to SDE(T) is circulated **as per the list enclosed as Annexure -I for eligible executives only.**

Further, in accordance with the said Judgment and their eligibility against Vacancy years 1994-95 to 1996-97 (Upto 22.7.1996) these Eligible Executives in Annexure-I are placed enblock below to that of those Executives who have passed Qualifying examination prior to 1996 and in accordance with the para 31 of Judgment of Hon'ble CAT, Ernakulam dated 05.02.10 and upheld by Hon'ble High Court Judgment dated 01.07.2013. Thus the Seniority of these Executives are placed below Shri M. Jothappa, Staff No. 37267, Sen No. 19992.502, last executive passed the Exam in 1991 and inter-se-seniority among these 42 eligible executives **(147 group of LDCE executives)** is fixed in accordance with their eligibility for a vacancy year and merit position.
6. The seniority of the remaining **96 ineligible executives** (Annexure-II) will be issued separately after analyzing their position in SDE grade at par with their juniors promoted under SCF quota only as per RR 1996/2002. However, if these executives have qualified LDCE-2002 on merit, they will be given seniority in accordance with the rank obtained.

This issues with the approval of the Competent Authority.

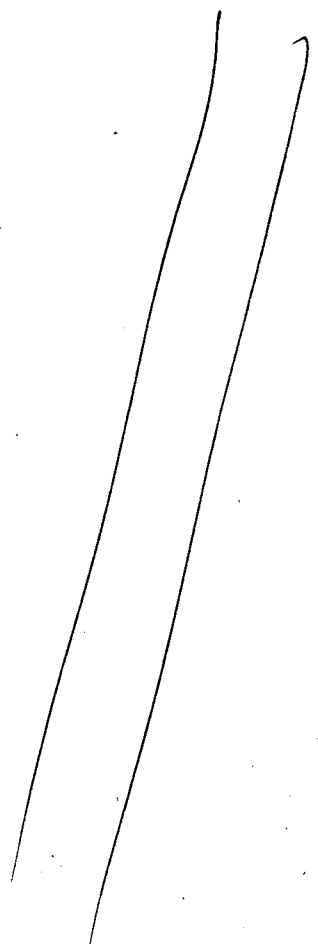
