Abnormal delay in issuance of Own cost Request transfers in respect of Accounts Personnel who have completed more than 2½ service in Other Circles and request for consideration of the same on Humanitarian grounds-reg.

## Respected Sir,

We would like to draw your kind attention on the above cited subject. In this regard, it is submitted that we had requested the Management several times for the past five months to consider the own cost request transfers in respect Accounts Personnel working in other than their Home Circles, who have already completed more than 2½ service in other Circles.

It is pertinent to mention here that while we had discussed with Director (HR) and PGM (Pers.) during the month of June 2020, it was assured that these request transfers will be considered shortly. Meanwhile, due to 2<sup>nd</sup> Membership Verification guidelines, the request transfer orders of Accounts Personnel were not issued and held up, whereas the own cost request transfers orders were issued by the Pers. Branch of BSNL CO for all other cadres before the cut-off date of MVP guidelines i.e. on 26.6.2020. The issue was again taken up by the AIBSNLEA with the PGM(Pers), but it was stated that the transfer orders could not be approved by the Competent Authority since file has been submitted belatedly i.e., after 26.6.2020. Finally, it was assured that these request transfers will be considered after the 2<sup>nd</sup> MV.

We are on the fond hope that the own cost request transfers will be considered after the completion of 2<sup>nd</sup> MV. The issue was again discussed with Director(Finance) on 24.8.2020 and with Director (HR) and PGM(Pers) on 25.8.2020 after the completion of 2<sup>nd</sup> MV. It was stated that the cases are under process and assured that the orders will be issued shortly. To our surprise, so many request transfers orders were issued by the Pers.Branch in respect all the cadres for the past 20 days after the 2<sup>nd</sup> MV except the above said own cost request transfers of Accounts Personnel.

We have already impressed upon the Director(HR), Director(Fin) and PGM(Pers) that these Accounts Personnel are facing so much problems due to Covid-19 in other than their Home Circles and further requested to consider the transfer requests on Humanitarian Grounds so as to join with their families.

In view of the foregoing, we would request your good self to kindly intervene in the matter and cause to issue necessary instructions to the Officers concerned to consider all the eligible pending own cost request transfers of Accounts Personnel sympathetically so that they can join with their family in the Covid-19 Pandemic Situation as their Families are residing in their Home Circles and feel isolated and humiliated.
