

SNEA vide their letter number SNEA/CHQ/CMD/2015-18/94 dated 25th June, 2018 has raised the issue but has forgotten that in the last term Shri G.L. Jogi was the CHQ President who retired in June 2013 and continued till their next All India Conference held in 2015 at Jaipur.

That time AIBSNLEA never raised such type of issues which are against the trade union ethics but the BSNL Management as per the recognition rules directed GS, SNEA to take the corrective action but GS, SNEA referred the provision of constitution of SNEA and requested the Management that he should be allowed to hold the post of CHQ President up-to AIC and accordingly, Management allowed Shri Jogi as CHQ President who presided over the AIC at Jaipur. Similar are the provisions of AIBSNLEA also.

In view of the above, we would request you to kindly consider our request to allow our CHQ Office Bearers who retired during this term till next AIC as per the provisions of the constitution of AIBSNLEA and its smooth functioning.
