**RECRUITMENT RULES OF DEPUTY GENERAL MANAGER (DIRECT
RECRUITMENT) OF TELECOM OPERATIONS STREAM-2024**
No. BSNLCO-PERS/15(17)/3/2023-PERS1 **Dated: 26.02.2024**

1. Short Title and commencement:

With the approval of BSNL Board and in supersession of the Recruitment Rules [2008] of Directly Recruited DGMs of BSNL Management Services and subsequent amendments/modifications thereof, the following rules regulating the method of recruitment to the post of Deputy General Manager (DR) of Telecom Operation Stream in Bharat Sanchar Nigam Limited (BSNL) are hereby made:

- (i) These rules may be called as **Recruitment Rules of Deputy General Manager (DR) of Telecom Operations Stream-2024**.
- (ii) Recruitment Rules of Deputy General Manager (DR) of Telecom Operations Stream-2024 will be part of Recruitment Rules of BSNL Management Services-Telecom Operations Stream-2023.
- (iii) These rules shall come into force with effect from the date of notification.
- (iv) Powers for relaxation/modification/amendment to these rules will vest with the BSNL Board.

2. Definition: In these Rules unless the context otherwise requires,

- (i) **Company:** Means Bharat Sanchar Nigam Limited (A Government of India Enterprise) hereinafter called BSNL, having its Registered Office at Bharat Sanchar Bhawan, Janpath, New Delhi.
- (ii) **Board:** Means the Board of Directors of the Company and includes in relation to the exercise of powers by any Committee of the Board/Management or any other Officer of the Undertaking to whom the Board delegates its powers.
- (iii) **Functional Stream:** Means the discipline to which the Executive has been recruited.

3. Application: These Rules shall apply to the post as specified in Column (1) of the Schedule annexed to these Rules.

4. Appointing Authority: Appointing Authority will be CMD, BSNL.

5. Authorised strength and Scale of Pay:

The authorized strength as given in the BSNL MSRRs-Telecom Operations Stream-2023, which is subject to change as per review by Manpower Plan, is as under:

The requirement of DGM(DR) shall be worked out before each recruitment process based on the actual need and requirements of the company.

6. Method of Recruitment, age limit, qualifications, probation etc.:

The method of recruitment, age limit, qualification and other matters relating to the said post shall be as specified in Column 5 to 13 of the Schedule annexed.

7. Selection Process: The selection process will consist of Written Test and Interview as per details of Scheme and Syllabus of DGM(DR) exam to be notified separately with the approval of Management Committee of BSNL Board.

8. Bond: All the recruited candidates shall execute a Bond in the format as specified by the Company to serve in BSNL for a period of five years/age of attaining date of superannuation, whichever is earlier, from the date of their appointment or for a period as specified by BSNL for the post, from time to time. The Bond amount will be of Rs.10 lakhs for calendar year(s) 2024 and 2025 and for the calendar year(s) 2026 and 2027 and the same will be of Rs.11 lakhs. Thereafter, this limit shall be reviewed.

9. Training and Probation: All DGM(DR) will remain on probation for two years which will include one year of Specialized Classroom as well as Field Training followed by examinations, as per details given below:

9.1 Institutional Training (Classroom based) – Total 11 Weeks

9.2 Field Training – 39 Weeks

9.3 Management Training - 2 weeks

9.4 If any of the candidates fails to successfully complete the training including the examination during training, then his/her probation shall be extended by 6 months, followed by Examination. He/ She will be placed below in seniority than the candidates who have already cleared the exam.

9.5 On failure in successful completion of training including examinations during the period of training even in extended period, his/her appointment/selection to BSNL shall be treated as cancelled.



10. Career Progression: The career progression of candidate finally selected and appointed for the post of DGM(DR) of Telecom Operations Stream shall be regulated as per provisions of Recruitment Rules of BSNL Management Services-Telecom Operations Stream-2023.

11. Seniority: Seniority of candidates selected and appointed as DGM(DR) of Telecom Operations Stream will be as per final merit list to be prepared on the basis of marks obtained in the prescribed selection process. Further their inter-se-seniority in the DGM grade and higher grades shall be regulated in accordance with the provisions of Recruitment Rules of BSNL Management Services-Telecom Operations Stream-2023.

12. Disqualification:----No Person:-

a) Who has entered into or contracted a marriage with a person having a spouse living,

or

b) Who having a spouse living, has entered into or contracted marriage with any person,

shall be eligible for appointment to the said post.


Provided that the Appointing Authority may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

13. Saving: Nothing in these rules shall affect reservations, relaxation of age limit and other concession required to be provided for the Scheduled Castes, Scheduled Tribes, Other Backward Classes, PwBDs, and other special category of persons in accordance with the orders/guidelines issued by the Central Government from time to time in this regard.

14. Liability to serve anywhere in India: Persons appointed to the post of DGM(DR) shall be liable for transfer anywhere in India/ at any place falling in the operational area of BSNL.

15. Residuary matters: In regard to matters not specifically covered by or under these Rules, the persons appointed will be governed by the rules, regulations and orders decided upon by the Company.

16. Interpretation:- Where any doubt arises as to the interpretation of any of the provisions of any of these rules or the regulations made there under, the matter shall be referred to BSNL Board whose decision shall be final.



RECRUITMENT RULES OF DEPUTY GENERAL MANAGER(DR) OF TELECOM OPERATIONS STREAM-2024

(I) Educational qualifications

Essential Qualification

Bachelor of Engineering/ Bachelor of Technology degree or equivalent Engineering Degree with minimum 60% marks on a regular full time basis in any of the following discipline:

1. Electronics & Telecommunication
2. Electronics
3. Computer Science
4. Information Technology
5. Electrical
6. Instrumentation

Or combination of these discipline as core with other associated emerging branches.

The candidates should be Indian National and should possess the requisite educational qualification from an Indian Institute/University established by/under Act of the Central/State Government in India or other educational institute established by an Act of Parliament or declared to be deemed University under Section 3 of UGC Act, 1956 and should have completed the course as on closing date for receipt of applications from the candidates.

(II) Experience:

Candidates from Public Sector, Private Sector and Government are eligible to apply for the post of DGM(DR) of Telecom Operations Stream. All candidates, however, must fulfill all the three criteria given as under:

1. Minimum 12 (twelve) years of post-qualification working experience as on closing date for receipt of applications from the candidates.


2. Requisite experience, as on closing date for receipt of applications from the candidates:

(i) In case of Public Sector, candidate must be Regular AGM or equivalent in E4 or higher IDA Pay Scale with 03 years of regular service in AGM or equivalent in E4 pay scale, or

(ii) In case of Government Sector, candidate must be Under Secretary and equivalent grade officers in Pay matrix Level-11 (as per 7th CPC)/Pay band 15600-39100 with GP 6600 (as per 6th CPC) CDA Pay Scale or higher Pay Scale with 03 years of regular service in Pay matrix Level-11 (as per 7th CPC)/Pay band 15600-39100 with GP 6600 (as per 6th CPC) CDA pay scale Or

(iii) In case of Private Sector, candidates must have minimum Gross Salary of Rs. 15 lakh per year, as per Form -16/ITR, during any of the financial year 2022-23 or 2021-22, for vacancies to be notified in the Year 2024. This limit of minimum gross salary will increase automatically by 5% (non-compoundable) per year and accordingly Form-16/ITR have to be seen for the relevant years.

3. Minimum 05 (five) years of work experience, in a Company with an annual turnover of more than Rs.100 Crores (in case of PSU, Private Company) in the preceding 05 financial years with reference to the year of issue of advertisement for the recruitment.
