

- 2.0 This promotion order is subject to the provisions of the DOP & Trg OM No 22011/4/91-Estt(A) dtd 14.09.1992.
- 3.0 The current vigilance status of the executives shall be obtained and specific posting to the sensitive/ non-sensitive posts shall be done by Sr.CEs/CEs (E) as per the prescribed norms circulated by the DOT / Vigilance Cell BSNL CO from time to time.
- 4.0 The Executives may be relieved immediately as per specific posting orders so as to enable them to join the assigned place of posting at the earliest.
- 5.0 The promotion shall be effective from the date of assumption of charge of the post of SDE (E).
- 6.0 In case, the Executive(s) concerned fails to join with-in the prescribed time period of 40 (forty) days, the executive(s) shall not be allowed to join the post thereafter. In such an event his/her promotion order shall become inoperative and the matter shall be reported to this office for further necessary action.
- 7.0 The leave, if any requested by the executive, under promotion, shall not be granted by the controlling officer where they are working presently.
- 8.0 The above promotions are subject to the outcome of court case(s), if any, pending before the Hon'ble Court(s)/ Tribunal(s).
- 10.0 Executives at S. No 28, 58 & 60 are already promoted to the grade of SDE (E) on provisional basis as per promotion order No 17-1/2005-Electrical (Pt) dated 29.09.2011 in compliance of order dated 16.12.2010 of Hon'ble Tribunal Hyderabad in OA No 314/2009 (S.Jeevan & Ors v/s BSNL) subject to outcome of WP No 6578/2011 filed by BSNL pending before Hon'ble High court Hyderabad.
