- 4. No leave shall ordinarily be granted to the executive until he/she joins the promoted post. Further the executive under transfer to other Unit/Circle may be relieved immediately to join the promoted post immediately and within the specified time.
- 5. The pay of the executive promoted shall be fixed in accordance with provisions of BSNL MSRRs-2009.
- 6. The above promotion order is being issued after obtaining the vigilance clearance from Vigilance Branch of BSNL CO. However, in case, it comes to the notice of the concerned controlling authority that any disciplinary case is pending or any penalty is in operation against the executive, the executive should not be promoted without obtaining the specific approval of this office.
