Subject: To waive off installation charges for LL/DSL/Bharat Fibre/BBoWiFi/Bharat AirFibre (Voice/Broadband) connections in all the circles.

Kindly refer to the letter No. 1-1/2020-R&C (CFA)[Circular R&C-CFA No.37/20-21] dated 14-09-2020 regarding installation charges.

- 1. Now, competent authority has decided "to waive off installation charges of Rs. 250/-(for Cu connections) or Rs.500/- (for Bharat Fibre connections) currently levied on BSNL's LL/BB connections (Cu/Fibre/BBoWiFi/Bharat Air Fibre) on promotional basis till 30-04-2021 in all the circles".
- 2. The circles shall ensure to comply with all regulatory requirements including on line reporting to TRAI and also update the circle website.
- 3. The above instructions shall be applicable with immediate effect, <u>on promotional basis for a period up to</u> <u>30-04-2021 in all the circles.</u>
