Sir,

We wish to bring your kind notice that to revoke the charges against Shri Samir Kumar Saha, SDE staff No.100142 and get the proper judgment from your office.

FACT OF THE CASE: A charge sheet under Rule 14 of CSS rules was initiated against Shri Samir Kumar Saha, SDE Staff No.100142 vide memo no.2001/A/7 dated 27.01.2006 of CGM CTD. The proceedings continued for more than 10 months. The enquiry officer submitted a report to the competent authority with the findings that the charges are not proved in the court of enquiry. On memo was issued to the officer as the disciplinary authority was disagreed with the findings of the enquiry authority.

Shri Samir Kumar Saha submitted the reply to the Hon'ble member(Services) on 03.12.2007 stating the whole fact in details for exonerating him from the charges but the natural justice was denied and he was victimized with the remarks "Pay of Sri S K Saha SDE to reduce by one stage in the time scale of pay till his retirement on 30.09.2009". It was further directed that "Sri S K Saha, SDE, will not earn increments of his pay during the period of such deductions and on expiry of the period the reductions will have the effect of postponing the future increments of his pay. This order will come into effect immediately".

Sir, it will not be impertinent to add here that he has been serving the Department with utmost dedication & efficiency, for which he was duly appreciated by the higher authority.

It is therefore we appeal to your good-self to revoke all charges against him and expect to get the proper justice from your office,
