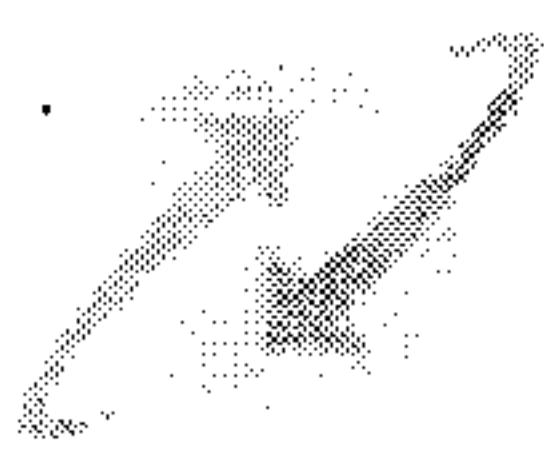



Subject: Deduction of monthly subscription from the salary of the members and remittance to AIBSNLEA – our submission on practical difficulties.

Respected Sir,

On the subject cited above, it is submitted that as per the Govt. orders, PAN Card is now a days mandatory for operating bank accounts. AIBSNLEA being a single legal entity, registered under the Society Act, is eligible for a single PAN Card and the same PAN Card has to be utilized by all Circle/SSAs. Further, as per the IT Act, we would have to submit the ITR every year for the consolidated accounts of CHQ, Circle and SSAs.

To facilitate this, AIBSNLEA has decided to remit the full subscription (Rs. 50/- per month) to a single account of AIBSNLEA CHQ with a single vender code and single payee linked in ERP to enable deduction of the subscription from all the AIBSNLEA members throughout the country and remitted to CHQ account through ERP.
