This commendable initiative has not only resulted in the release of a long-pending judgement on 26-Feb-2024 (OA No.060/1435/2018) but has also paved the way for significant progress within the organisation.

We acknowledge the involvement of AIBSNLEA as a party in the aforementioned case through our advocate, and we are pleased that our collective efforts have contributed to the timely pronouncement of this crucial judgment. With the recent vacation of the status quo through this judgement, we believe that the BSNL management now has the opportunity to explore all possible avenues for the swift issuance of long-awaited promotion orders, beginning with AOs to CAOs, particularly in the Finance stream.

Sir, we firmly believe that there should be no impediment to promoting eligible Account Officers (AOs) to Chief Accounts Officers (CAOs) in accordance with the provisions outlined in the old MSRR 2009, as preserved by the BSNL management during the adoption of MSRR-2023. Furthermore, we urge the

expedited publication of year-wise seniority lists for AOs to facilitate the prompt issuance of their CAO promotion orders.


