Subject: Review of guidelines for empanelment of officers for holding the post of Chief General Manager (CGM) in BSNL- regarding.

The guidelines for empanelment of officers for holding the post of Chief General Manager (CGM) in BSNL were notified with the approval of Management Committee of BSNL Board vide BSNL CO letter No. BSNLCO-PERS/15(11)/5/2023-PERS1 dated 20-04-2023.

- 2. DoT vide ID Note No. 9-5(4)/2024-Estt. dated 20-Jun-2024 has intimated that the said empanelment process adopted by BSNL is not tenable for ITS cadre posts being operated in BSNL as per cabinet approval. It was also intimated that the sanctity of the HAG promotion granted to ITS officers after DPC conducted by UPSC and with approval of ACC is inviolable for cadre posts and directed BSNL to comply with its directions conveyed therein with immediate effect.
- 3. In view of the aforesaid directions of DoT, the Management Committee of BSNL Board has reviewed the above-cited empanelment guidelines dated 20-04-2023 and have now approved the following:
 - (i) The existing guidelines for empanelment of officers for holding the post of Chief General Manager (CGM) in BSNL issued vide BSNL CO letters dated 20-04-2023 & 26-05-2023 stands withdrawn with immediate effect.
- (ii) The existing panel of officers empaneled for holding the post of CGM in BSNL stands lapsed with immediate effect.
- (iii) Officers from regular ITS HAG and HAG NF level ITS officers will be identified and shall be posted as CGM in BSNL, strictly as per the directions issued by DoT vide iD Note No. 9-5(4)/2024-Estt. dated 20-Jun-2024.

- (iv) The tenure as CGM, of the officers appointed through empanelment process will end, as soon as the new officers are posted as per the directions of the DoT dated 20-Jun-2024.
- (v) The case of absorbed/directly recruited officers of BSNL for holding the post of CGM shall be taken up separately in due course.
- 4. The revised instructions shall come into force with immediate effect and until further orders.

This issues with the approval of competent authority.
