Sub: Request for provision of Residential FTTH Service Connection to the Serving BSNL Executives as well as to Retirees-reg.

Respected Sir,

We would like to draw your kind attention on the above cited subject. In this regard, we wish to submit that though serving BSNL Executives are allowed Concessional Broadband connection over Copper Media at their residence as per their entitlement but this benefit has not been allowed so far in case of FTTH connections for higher Data Speed. In ADSL Broadband connection, one can get only Internet speed of about 7-8 Mbps and internet speed depends on the Copper Conditions in the respective O/D Field Unit.

It is a well-known fact that due to Covid-19 pandemic situation most of the BSNL Executives as well as Retirees are using concessional BSNL Broadband (ADSL) for work from home. As the internet speed for ADSL Broadband connections is limited up to 7-8 Mpbs, therefore they can't work efficiently and the need of FTTH connection is fully justified.

In view of above, AIBSNLEA suggests that the below mentioned FTTH Plan may kindly be allowed on concessional basis in addition to the entitlement already availed by the Serving Executives and BSNL Retirees, which will earn more revenue to BSNL.

- 1) FTTH Plan of 500 GB_CUL Monthly [Up to 50 Mbps till 500 GB and 2 Mbps beyond] for the Executives up to the level of SDE/AO/Sr.AO and equivalent.
- 2) FTTH plan of 750 GB_Plan_Monthly [Up to 100 Mbps till 750 GB and 2 Mbps beyond] for the Executives to the level of DE/CAO/EE (equivalent) & above.
- 3) FTTH Plan of 500 GB_CUL Monthly or FTTH plan of 750 GB_Plan_Monthly to the BSNL Retirees as per their entitlement.

Sir, if above mentioned FTTH Plans are allowed to BSNL executives then in each FTTH connection, BSNL will get more than Rs.400/- per connection per month (beyond the concession) and this will help to maximize the revenue of BSNL as a revenue of around Rs.1.20 crore per month only from the serving Executives can be earned and moreover these are our Good Debtors.

We would, therefore, request your good self to kindly cause to issue necessary instructions to the officers concerned to extend the facility of FTTH connection to the Serving Executives at their Residential Service Telephone Connection as well as to the Retirees of BSNL as mentioned above.
