Plan Name	Price (inclusive of service tax)	WiFi Duration
BSNL WiFi free	NIL	First 20 minutes in a day for maximum 3 occasions in a month for the same mobile number
BSNL WiFi 30	Rs. 30/-	30 minutes
BSNL WiFi 50	Rs. 50/-	60 minutes
BSNL WiFi 90	Rs. 90/-	120 minutes
BSNL WiFi 150	Rs. 150/-	One day
