# Subject : Amendment to the provisions of the Constitution of All India Bharat Sanchar Nigam Limited Executives' Association - reg.

#### Ref. : AIBSNEA/CHQ/84/2006-07 dated 28.07.2006

Sir,

This is in continuation to our above referred letter submitted after 1<sup>st</sup> All India Conference held at Hyderabad on 11<sup>th</sup>, 12<sup>th</sup> and 13<sup>th</sup> January 2006. The 2<sup>nd</sup> All India Conference of All India Bharat Sanchar Nigam Limited Executives' Association held at Jaipur on 28<sup>th</sup>, 29<sup>th</sup> and 30<sup>th</sup> Aug 2008 and the Representative Council passed certain amendments in the constitution of the Association. Amendments approved under heading "RULES AND REGULATIONS" in the constitution of AlBSNLEA, passed by the 2<sup>nd</sup> AlC at Jaipur are enumerated below for intimation please :

#### Amendment No. 1 :

#### Existing Clause no. 8 (ii) (a)

...... "The Central Office Bearers shall Comprises of the following :- One President, Two Vice President, One General Secretary, Four Assistant General Secretaries, One Financial Secretary, One Assistant Financial Secretary, Four Organising Secretaries – One From Each reason and One Editor for its monthly journal. Out of four Assistant General Secretaries one post each shall be reserved for the members from Telecom Engineering, Finance & Accounts, Civil/Electrical/ Arch. Wing / Telecom Factory and General Line Disciplines.

#### Modified clause no. 8 (ii) (a)

...... "The Central Office Bearers shall Comprises of the following :- One President, Two Vice President, One General Secretary, Five Assistant General Secretaries, One Financial Secretary, One Assistant Financial Secretary, Four Organising Secretaries – One From Each reason. Out of four Assistant General Secretaries one post each shall

be reserved for the members from Telecom Engineering, Finance & Accounts, Civil/Electrical/ Arch. Wing / Telecom Factory and General Line Disciplines. The fifth AGS post shall function as AGS (HQ) and Open to all disciplines. Additionally there will be six posts as Advisors one from each region of East, West, South, North, Central and Headquarter.

## Amendment No. 2 :

### Existing Clause no. 8 (vi)

- (h) Editor
- (i) Shall Edit the Journal of the Association
- (ii) Shall be responsible for the dispatch of the journal to the members
- (iii) Shall assist the General Secretary for Printing and Publishing of the journal

#### Modified Clause no. 8 (vi)

8 (vi) (h) Advisor

8 (vi) (h) (i) Shall co-ordinate the activities of the Association in respective areas for over all improvement of the organization

### Amendment No. 3 :

#### New Clause 8 (vi) (b) (iv)

AGS (HQ) in addition to the duties mentioned at Clause no. 8 (vi) (b) (i) to (iii) shall assist the General Secretary for Editing the Journal of the Association, for the dispatch of the journal to the members and for Printing & Publishing of the journal

#### Amendment No. 4 :

#### Existing Clause 8 (c) (b) (e)

The Branch Committee shall collect subscription, Keep accounts and remit quota as under -

60% of the subscription to the Central HQs, 20% of the subscription to the Circle and retain 20% for the subscription for meeting branch expenses. The quota of the Central and Circle shall be the First Charge on subscription collected in that order and shall be remitted direct to the CHQ / Circle.

#### Modified Clause 8 (c) (b) (e)

The Branch Committee shall collect subscription, Keep accounts and remit quota as under -

Out of total subscription of Rs. 30/-, Rs 15/- to the Central HQs, Rs. 8/- to the Circle and retain Rs. 7/- for meeting branch expenses. The quota of the Central and Circle shall be the First Charge on subscription collected in that order and shall be remitted direct to the CHQ / Circle.

#### Amendment No. 5 :

#### Existing Clause 8 (ii) (b)

Circles shall have one additional member to the Central Working Committee for every 300 continuous paid membership who are to be elected by the respective Circles at their Circle Conference / General Body meeting.

#### Modified Clause 8 (ii) (b)

Circles shall have one additional member to the Central Executive Committee for every 300 continuous paid membership, subject to minimum one per Circle having minimum 150 membership, who are to be elected by the respective Circles at their Circle Conference / General Body meeting.

#### Amendment No. 6 :

#### New Clause 8 (ii) (d)

The General Secretary / Circle Secretary / Branch Secretary who will be superannuating from the services shall be **Permanent Invitee Member** to the CWCs/CECs respectively.

#### Amendment No. 7 :

#### New Clause 15 (v)

No member shall hold same office bearer post at same level for more than three consecutive terms subject to extension for one more term with the approval of Representative Council.
