We would be happy to see that your kind words to us get translated into action by the Personnel section without further delay.

We feel it worthy to mention here that the Director, AIIMS- Bhubaneswar has granted extension of one month to Sri Sanjay Kumar Mohanty and it is going to expire in the mid-week of May. The said extension letter is enclosed for your kind reference. It is also fact that if one Sr SDE© in the pay scale of E4-E5 is allowed to go on deputation for three years, BSNL will save more than 40 Lakhs.
