Subject Transfer & Posting on "Pick and Choose" method and in the interest of service even before completion of ONE YEAR of service at present station in JAG [DGM (Fin)] and non-consideration of genuine medical and immunity ground cases-Reg.

Reference SEA order No- 1-7/2018-SEA BSNL dated 04.10.2018

Respected Madam,

With reference to above subject we are constraint to bring to your kind notice that the transfer orders in Finance Wing- SEA Section of Corporate Office are being issued on Pick & Choose method and even without mentioning OWN COST before the completion of one year of service in Corporate Office as may be seen from the SEA section order mentioned under reference above ignoring the tenure / stay particulars for which the reasons are best known to SEA Cell BSNL Co.

For example Sh Hanuman Sahai Gurjar, JAG of Telecom Accounts & Finance Services (DGM (Fin) Staff No 88748 who joined in BSNL Corporate Office on 12.10.2017 and even before completion of One Year of his service in CO BSNL he has been transferred to Rajasthan Circle vide orders dated 04.10.2018 mentioned under reference and even with Company Cost.

Besides above, some other cases of DGM (Finance), those who have already completed more than two years of service in CO BSNL and Jharkhand Circle etc and their requests on their family problems and health grounds are pending with SEA Section, they have not been transferred even their own cost request. For Example:

- 1. Sh. Prem Chand Khandelwal DGM (CA) BSNL CO requested for Rajasthan Circle, who has joined in CO BSNL on 09-02-2016 and has already completed two year and 8 Months of service as on date.
- 2. Sh. Ram Chandra DGM (F) Hazaribagh requested from Jharkhand to UP(E) Circle on Medical ground and having less than two years' service in retirement. His application has also been forwarded by CGMT Jharkhand Circle.

Similarly some other genuine medical ground and immunity ground request transfer cases have also not been considered since long despite of our repeated requests like:

1. M S Sherila Ajith AO Kerala Circle suffered from brain stroke and has been transferred and relieved six months before and now without salary. She has requested for retention in Kerala Circle on compelling medical ground. As per doctor's advice, she cannot travel continuously for more than 4 hours. She cannot travel by Air also. At this juncture she needs help. For the last six months she is on leave without pay.

2. Shri Khursheed Anwar AO (ETP) Ranchi transferred to Bihar Circle requested for retention in Jharkhand Circle. His application has been forwarded by CGMT Jharkhand also.

3. Shri G C Grover, AO Haryana Circle transferred to J&K Circle has requested for retention under immunity ground as he is District Secretary of AIBSNLEA.

It is therefore humble request to kindly intervene in the matter and take appropriate step to amend the above unjustified transfer order of Shri H S Gurjar DGM (F) and settle all the above mentioned genuine requests at the earliest.
