**Subject: Appointment of "Junior Accounts officer on probation" under DR quota consequent on completion of 11 weeks of pre-appointment Training on 20.05.2019 for second Merit list of batch 2018 – Reg.**

**Respected Sir,**

We would like to draw your kind attention on the above cited subject. In this regard, it is submitted that 33 DR (JAO) Candidates who have successfully completed Phase-I training from 29.7.2019 to 2.8.2019 at NATFM, Hyderabad were relieved from training centre with instructions to report the concerned Circles for further orders.

Out of the above 33 DR candidates, 12 candidates who were allotted to West Bengal Circle and ETP Circle Kolkata have reported in West Bengal Telecom Circle, Kolkata on 5.8.2019.

Generally, Appointment orders are being issued from Corporate Office before completion on Phase-I Training and based on such order, Circle Office ordered place of posting and candidates will join as JAO at their place of posting directly after relieved from Training Centres.

But in this case, due to non-issuance of Appointment order in time from Corporate Office, all the successful candidates have reported to Circle Office, West Bengal Telecom Circle, Kolkata on 5.8.2019 and joined as JAO at their respective place of posting on 13.8.2019 after issuance of appointment order from Corporate office, BSNL, New Delhi and subsequently from Circle Office, West Bengal Telecom Circle on 9.8.2019 (copy enclosed).

In this regard, Kindly find enclosed herewith the letter addressed to PGM (Pers.) BSNL CO by the GM (Finance) seeking clarification.

In view of the foregoing, we, would therefore, request your good self to kindly intervene in the matter and cause to issue necessary instruction to the officers concern to pre pone the date of appointment of "Junior Accounts officer on Probation" under DR quota from 13.8.2019 to 5.8.2019 to avoid anomaly between the juniors and seniors of the same batch who have already joined in other Circle on 5.8.2019.
