## Dear Madam,

At present after removal of 60:40 pension sharing system, the responsibility of Payment of Pension to BSNL Pensioners lies entirely with Government of India from its consolidated fund. But still the old system of sending the sanctioning memo by BSNL along with the calculation sheet continues for pension revision of BSNL pensioners. This involves huge manpower of BSNL circles which is practically wastage. For the recent 78.2% pension revision job of about 1.5 lakh pensioners, almost one year is over still more than 30,000 pensioners are yet to receive their revised pension. Although the pension revision of other Central Govt Employees as per 7th CPC completed smoothly and quickly as it was done directly by the pension disbursing banks.

The recommendations of 3<sup>rd</sup> PRC is going to be implemented very soon. It is also expected that the pension of pensioners retired before 1-1-2017 will also be revised in the same line as of BSNL executives. This time the total number of pensioners will be more than 2 lakhs. Now if BSNL has to carry out the job of preparing sanction memo and calculation sheet for these 2 lakh pensioners, it has to engage huge manpower which is completely unnecessary as the job can easily be done in the same line as 7th CPC recommendations were implemented for Govt. pensioners. At present BSNL has no responsibility of payment of pension and its revision for the pensioners already retired, then why they should carry out the load of preparing sanction memo and calculation sheets. However for the pensioners who retired after 1-1-2017, there pension revision involves pay revision also and that job has to be continued to be executed by BSNL only.

We therefore request you to kindly consider the proposal and if approved, to take up with DOT for implementation. This will eliminate huge harassment and delay caused to the BSNL pensioners as at present.
