
Subject: Applicability of foot note-1 below Schedule IA, IB, IC & ID of BSNL MS RR-2009 – clarification on implementation thereof.

Instances have come to the notice of Personnel branch of BSNL C.O. where the time bound pay upgradation admissible under Note 1 below Schedule IA, IB, IC & ID of BSNL MS RR-2009 has been implemented erroneously. The Note 1 which is common to all the Schedules in the BSNL MS RR-2009 is reproduced as below:-

*"The IDA pay scales of the executives of group "A" level, either absorbed or directly recruited by the Company, belonging to IDA pay scale of **13000-350-18700 & 14500-350-18700** will be upgraded to IDA pay scale of 14500-350-18700, 16000-400-20800 and 17500-400-22300 as per attendant conditions circulated under 400-61/2004-Pers I dated 18.01.2007. This will be in case any executive **belonging to such levels** does not get post based promotion corresponding to next grade in a period of 4-6 years."*


The import of the above lines is that only those executives covered under BSNL MS RR-2009 who are availing the pay scales of Rs.13000-350-18700 [E3 pre-revised] and Rs.14500-350-18700 [E4 pre-revised] can be considered for time bound IDA pay upgradation to pay scales of Rs.14500-350-18700, Rs.16000-400-20800 and Rs.17500-400-22300 within the provisions of Executive Promotion Policy [EPP]. Any other level executives viz. DGM and above are not eligible for consideration under the EPP as their time bound upgradation to NF grades is already enshrined in the BSNL MS RR-2009.


Any case contrary to these guidelines shall be corrected immediately under intimation to this office. This issues with the approval of competent authority.

Subject: Applicability of E6 IDA pay scale upgradation under EPP to Gr. B absorbees working as DGM on adhoc basis *clarification thereof.*

The undersigned is directed to refer to this office letter no. 400-66/2011-Pers.I dated 25-07-2012 clarifying that DGMs[regular] are not entitled for E6 IDA pay time bound scale upgradation under EPP as DGM(regular) & above for their time bound upgradation to NF grade are expressly covered under BSNL MSRRs-2009. Though the clarification dated 25-07-2012 is self explanatory in its intent and purpose, however some confusion regarding applicability of E-6 IDA pay scale upgradation to Gr. B absorbees working as DGM on adhoc basis has emanated.

The issue has been raised by some Circles/Associations/Individuals at different times. The matter has been deliberated in this office and it is hereby clarified that the Gr. 'B' absorbees working as DGM on adhoc basis (availing E5 pay scale) shall be eligible for consideration of time bound pay upgradation to E6 pay scale under the EPP if otherwise eligible on the same consideration as being done for other executives.

This issues with the approval of the competent authority.
