3. The officers now promoted, in case are officiating on local arrangement basis in the grade of JAG by an order of the Circle, then they should be reverted to their substantive grade and be promoted afresh in compliance with this order, after giving a break of one day.

4. The pay of the officers mentioned at sl no 1 to 9, 14 and 18 will be fixed under FR 22(I) a(i) with reference to their pay in the grade of STS and the pay of the remaining officers will be fixed under FR 22(I)a(i) read with FR-35, with reference to their pay in the grade of STS.

5. If the officers are on leave/training, they shall be promoted with effect from the date of joining, on return from such leave/training.

6. All the concerned IFAs may please check up the up-to-date position regarding the vacancies in the grade of JAG in their circle, after implementation of the above order and intimate the same to AO (SEA), CO BSNL, New Delhi this office.

7. Necessary charge report may be sent to all concerned, including AO (SEA), CO BSNL, New Delhi.
