Kindly refer to the above cited Hon'ble CAT Jodhpur bench judgement endorsed by the Corporate Office New Delhi, wherein it is instructed that all such promotes (Officiating JTO's, regularized as per provisions of new JTO (T) RR-2014) are informed of the existence of this OA, so that they can, if they want to get themselves, be impleaded

Judgement pronounced by Hon'ble CAT Jodhpur bench is not correct and it is in clear violation of JTO RR-2014 and an attempt to sabotage the very genuine absorption process of Officiating JTOs. The JTO RR -2014 has been formulated mainly for the regularization of Officiating JTOs working in the post of JTO for the past 12 years and they have undergone two terms of JTO(phase-I) training

In Tamilnadu Circle our Officiating JTOs had got clear verdict from Hon'ble CAT/Chennai vide OA.No.587/2013 that they have to be regularized against the vacancies upto 2000-01 and Hon'ble CAT/Chennai also questioned that how the persons who have completed seven years of Service as on 28.2.2013 made a claim to be accommodated on promotion against vacancies of the year 2001 or 2002 which was arisen before the date of their first appointment.

The same OA 587/2013 was uphold by the Hon'ble High Court, Chennai In the meantime CGM, TN Circle filed a SLP in Hon'ble Supreme Court, New Delhi. No interim Injunction was granted by the Hon'ble Supreme Court, New Delhi in this regard. After obtaining approval from Corporate Office, New Delhi LICE JTO-2013 passed TTAs were posted in TN Circle (after undergone required training) by giving an undertaking (Subject to the outcome of SLP)
