Kindly refer to the above cited letter. In this regard, we would like to draw your kind attention on the above cited subject and above cited reference under (2), wherein it was requested to issue necessary instructions to the concerned Officers for the settlement of Pay Fixation of Postal JAOs (Copy enclosed). In this connection the following are submitted for your kind consideration please:-

1. A Committee comprising of CGM (Legal), Sr, GM (EF), Sr, GM (Estt) and GM (SR) BSNL CO was constituted to re-examine the fixation case of Postal JAOs in the month of Nov 2018 and the committee submitted their report on 30.4.2019
2. It is learnt that the Committee, after thorough examination and scrutiny of all relevant records, finally recommended that the Pay of Postal JAOs, who joined BSNL from Govt. of India on their immediate absorption, may be fixed under GIO(10) Below FR22 of MOF OM No F.1 (11)-EIII (B)/69 , Dated 20.1.1970 and DP & AR OM F1(PII) 81 Dated 21.2.1983.
3. It is understood that the Committee had submitted their report in April 2019 itself . But till date, no action has been taken by the concerned Branch of BSNL CO for implementation of the Committee Report.

In view of the foregoing, we would, request your good self to kindly intervene in this matter and cause to issue necessary orders as recommended by the High Power Committee at the earliest and render justice..
