Sub: Revision of Seniority of TES Gr. 'B' in compliance with Hon'ble Supreme Court Judgement dated 21.1.2015 & 14.12.2017 in Civil Appeal No.4389 of 2010.

Ref: BSNL Co. ND Lr.No.56-04/2015 Pesrs(DPC)/Pt-111/19 dated 12.2.2019.

Respected Sir,

We would like to draw your kind attention on the above referred subject vide the Hon'ble Supreme Court New Delhi Judgement. The Hon'ble Supreme Court has upheld the Seniority list of TES Gr.B as per Rule-206 in its Judgement dated 14.12.2017. In compliance of the Hon'ble Supreme Court Judgement dated 21.1.2015 & 14.12.2017 in Civil Appeal No.4389 of 2010 Union of India * Ors. Versus Sohanlal Sayal & ors. And connected CA's Seniority list of TES Gr.B Executives has been recasted by the BSNL CO. vide letter referred above. There are so many discrepancies in the Seniority list and mainly we would like to brief as under:-

(1) As per the revised list the seniority number of persons who got their promotion as per Rectt Rule 1966 have been changed downgrade which is inviolation of Para 4 of Hon'ble Supreme court judgment dated 21-01-2015 which states that "those who have been given further promotions may not be disturbed " for Example Sh M R Belani staff no 9457 year of rectt 1968 passed TES Group 'B' Exam in 1987 was promoted as TES Group 'B' in Year 1988 and promoted as STS in Year 2002 assigned Seniority No 5139 as per Rectt Rule 1966 in list no- 3 .Now his Seniority Number revised from 5139 to 14097 which is in violation of decision of Hon'ble Supreme Court .As per the Hon'ble Supreme Court decision his seniority should have remain as 5139 and seniority of all the persons who passed the TES Group 'B' exam prior to Sh M R Belni should have been fixed over and above 5139.

(2)Similarly many SDE's promoted as DE in the year 2002 and 2003 on the basis of seniority of the year of Recruitment have now been reverted in violation of the Hon'ble Supreme court judgment Para-4 dated.21.01.2015.

In view of the above, it is therefore requested to kindly intervene in the matter and direct the Pers. Cell BSNL CO. to implement the Hon'ble Supreme court judgment in its true later and sprit to avoid further litigations.
