It is to bring to your kind notice that the following 3 SDEs have already served in hard tenure NE-II Circle during Aug 201 and they have reported back to Karnataka Circle.

In the mean time, all 3 above said SDEs have been promoted as DEs on adhoc basis and posted out side the Karnataka Circle due to non availability of vacancies in Karnataka vide BSNL CO ND letter No:412-12/2013-Pers-I. Dated 20/07/2013. Shri S K Hiremath SDE BGTD,KTK was retained upto 31/03/2014 on immunity ground since he is also District Secretary of AIBSNLEA BGTD Branch vide BSNL CO ND ltr No:412-12/2013-Pers-I.(pt.) Dated 31/07/2013.

As per the provisions in the transfer policy, they can not be disturbed at least 4 years in the place of working after serving in hard tenure place. Hence, all the 3 SDEs have represented for retention in KTK circle. However, BSNL CO has only retained Shri H Vishnumurthy Bhat Stno.33475 (SI no. 309) in KTK permanently but Shri S K Hiremath and Shri U S Mujawar are retained upto 31/12/2013 afterwards they should report to the Circle shown against their name vide BSNL CO ND ltr No:412-12/2013-Pers-I.(pt.) Dated 27/08/2013 which is a discrimination.

We would, therefore, request you to kindly remove this disparity by retaining Shri S K Hiremath and Shri Mujawar also in Karnataka Telecom Circle after 31/12/2013.
