We would like to draw your kind attention on the above cited subject. The Salary for the month of October' 2020 was due on 31.10.2020 but it has not been disbursed to BSNL Employees till date. The Monthly Salary has been disbursed to BSNL Employees belatedly for so many months. After the VRS is implemented in BSNL, the net monthly Salary expenditure has come down to around Rs.425/- Crore, but even after 09 months i.e., after the implementation of VRS-19, the BSNL Management is not in a position to disburse the Monthly Salary in time.

We are aware about the Commitment of the BSNL Management regarding the payment of Statutory dues viz., GST, TDS, EPF, Bank Interests & Quarterly Principal re-payment etc., and it is appreciable that the Management under your able Leadership, is paying almost all the Statutory dues in time and the major portion of Liabilities have also been cleared, but at the same time the BSNL Management has to understand that this is the Festive Month/Season and the Karwa Chauth, Dhanteras, Diwali, Laxmi Pooja, Bhai Dooj, Chhath Pooja & Eid-e-Milad festivals will follow in the Month of November' 2020 and BSNL Employees will also celebrate these festivals without much difficulty, if the Salary for the Month of October '2020 is disbursed immediately.

In view of the foregoing, it is requested that necessary instructions may kindly be issued to the Officers concerned for the disbursement of Salary for the Month of October' 2020 within the first week of November' 2020 so as to celebrate the festivals without much suffering.
