## **OFFICE ORDER**

Subject: Promotion and posting of JTOs to the grade of SDE (Telecom) in B.S.N.L. under Competitive Quota (33%) on the basis of Limited Departmental Competitive Examination held on 21.06.2015.

Pursuant to BSNL CO's Recruitment Branch letter No. 24-1/2014-Rectt. dated 20.04.2015 and 24-3/2015-Rectt. (Pt.) dated 15.05.2018 the Competent Authority in B.S.N.L. is pleased to promote the officers from JTO (T), as per the details in enclosed annexure, to the grade of SDE(T) against vacancy year 2010-11 under competitive quota (33%) in the IDA Pay Scale (E2A) of Rs.20600-46500/- from the date they assume charge of the higher post provided that:-

- i. They have been absorbed in B.S.N.L. on permanent basis;
- ii. No disciplinary/vigilance case is pending against him/her and no VC is withheld in terms of instructions issued by D.G.P&T/DoP&T from time to time.
- iii. The currency of any penalty against the officer is over;
- iv. The officer is not on deputation to any other organization.
- v. The officer has not retired on the date of issue of the order.
- vi. The officer has not resigned from the BSNL services.
- vii. They have fulfilled the prescribed eligibility of three years regular service as per SDE (T) RR
- viii. The officer has submitted the undertaking as per the enclosed format.
- 2. This office will decide such cases as detailed in Para 1 supra on receipt of information from concerned Telecom Circles. Information in this regard may be brought to the notice of this office immediately and the concerned officer should not be promoted without specific orders from this office.
- 3. Circle may issue the promotion order **subject to the vigilance clearance** and submission of necessary **undertaking** in the prescribed Format (enclosed) as per the direction of Hon'ble CAT Chandigarh Judgement in OA No. 060/00133/2015. In case of executives on deputation with BSNL, the Vigilance Clearance should be obtained from the recruiting circle also.

- 4. All CGMs concerned may please ensure that the promotion/posting orders in respect of officers found eligible after fulfilling the above conditions are issued in time to enable the officers to join their promotional assignment, within the prescribed time limit of 40 days (including the joining time) from the date of issue of this order.
- 5. In case the officer concerned fails to join the promotional assignments within the prescribed period of 40 days, he/she should not be allowed to join the post thereafter. In such a case, the promotion order shall become inoperative and the matter shall be reported to this office for further necessary action.
- 6. Subsequent to the promotion to the grade of SDE (T) this office shall consider the request of transfer to other Teritorial /Non teritorial circle as per the administrative requirement and the availability of the vacancy.
- 7. Discrepancies if any regarding name, present circle etc. in the Annexure may be intimated to this office immediately for issuing modifications/corrigendum.
- 8. The date on which the above order is being given effect by the circle may be intimated to this office, and accordingly, a consolidated report of the officers who have been relieved and have joined their new postings on promotion may also be forwarded to this office to assess relieving and joining status of the promoted officers.
- 9. The seniority of the officers promoted under this order shall be determined in accordance with the rules in force and will be issued separately.
- 10. The aforesaid promotion order is subject to the final outcome / decision in any lawsuit(s) pending before any court(s) regarding their regulation of seniority etc.
- 11. The relieving and joining particulars of officers may be updated in the ERP.
- 12. Pay fixation on promotion be done as per prescribed norms.
- 13. CGMs concerned may ensure that the requirement of manpower against New Projects such as NOFN/NFS/NCNGN/ITPC etc. may be fulfilled from these Officers promoted in their circles.
