Subject: Posting of SE (E), EE(E) & SDE(E) in Odisha Circle on priority basis.

## Respected Sir,

It is worthwhile to mention that Odisha electrical wing is carrying out all Installation & comprehensive maintenances of electromechanical services of all exchanges and BTS sites of Odisha telecom circle with the current manpower which is seriously undermanned. Many of them have been on call without rest. The pathetic condition is that there are no regular EE (E), no SE (E) and even no full time CE (E). The Sr. Chief Engineer (E) has since been transferred as Sr. GM (HR& Admn), Odisha Circle with additional charge of Sr. CE (E). It will be appreciated that in the absence of top & middle level management it is very difficult to manage the show. Odisha being a profit making Circle, BSNL can't afford to ignore it in respect of posting of judicious manpower.

Meanwhile MOU has been signed with Odisha Forest Development Corporation (OFDC) and Odisha Forest Department (Kendu Leaves) for carrying out all their infrastructure works for a span of three years. Presently this is worked out to be about 50 Crores which includes internal & external electrical installations also. As the work is going wider & larger and target oriented, filling up of all vacancies and adding some more executives is the way forward to be successful in generating additional revenue from all these external works.

In the light of foregoing paras, it is strongly demanded that:

- 1) Immediately fill up the SE (E) post which is lying vacant since Aug2015.
- 2) Immediately fill up four EE (E) posts which are lying vacant since couple of years.
- The sanctioned strength of 15 SDEs E) of Odisha Circle may be increased to 17 SDE(E)s at least by adding two more SDE(E)s for major external projects in similar line with Civil Wing.
- 4) Arrangements may kindly be made to post these two newly created SDEs (E) by modifying the current transfer order please.
