Subject: Request for cancellation of Transfer in the grade of SDEs (E) of Odisha Circle.

Reference: Your office letter no. 6-48/2016-Electrical Dtd. 27/05/2016.

Respected Sir,

We would like to bring to your kind notice about the irregularities in the inter circle transfer of SDEs (E) issued vide above stated letter particularly in respect of Sri Chanakya Pujari, SDE(E), O/o the CE(E), Bhubaneswar, HR No.199207231 and Sri Himansu Padhy, SDE(E), BSNL Electrical Subdivision, Cuttack, HR No. 199404954. As per the transfer policy, executives with longer stay in a particular circle are to be considered for posting in other circles including tenure postings. We are astonished to see that this has been blatantly violated in the current order.

Sri Chanakya Pujari joined in the office of CE (E), Bhubaneswar on 26/06/2015 after completing 5 years at soft tenure Koraput and is still holding the additional charge of Koraput. After deducting 3 years from his circle seniority he stands at 6 in longest stay list of Odisha Electrical Zone. It is also the policy that an executive after completing soft tenure should not be disturbed from choice posting at least for two years. Further he is the Asst. Circle Secretary in AIBSNLEA Odisha Circle and enjoys certain level of immunity. So transfer of Sri C. Pujari is not justified and therefore needs immediate cancellation.

Sri Himansu Padhy stands at 5 in longest stay list of Odisha Electrical Zone. He is having compelling family problems. A representation from Shri Himanshu Padhy is enclosed herewith for ready reference. In view of this the transfer of Sri C. Pujari is not justified and therefore needs immediate cancellation.

As far as postings of two SDEs (E) in Odisha Circle on own costs after completing their tenure postings namely Sri P.C. Patra SDE (E), HR No. 200006888 presently in UA circle and Sri M.K. Panda SDE (E), HR No. 200007345 of HP Circle are concerned, we strongly recommend that these two SDEs (E) should also join in Odisha Circle without any hitches. Considering that Sri Pujari & Sri Padhy continues in Odisha and no other longest stay gets transferred out, there is still one clear vacancy in the grade of SDE (E). One SDE (E) Sri D. Bhattacharjee has represented for transfer from Sambalpur, Odisha to WB Circle and his case has been recommended by the Sr. CE E, Bhubaneswar to your good office. If his case is considered two vacancies will arise and in that case Sri Patra & Sri Panda can join in Odisha Circle and Sri Pujari & Sri Padhy can continue in Odisha circle, By this generous move, all 5 executives will be happy and motivated and BSNL will not incur any expenditure towards transfer but will save huge money.

Furthermore, in Odisha Circle, out of 15 sanctioned/working strength of SDE (E), 4 SDE (E) are looking after in the grade of EE (E), thereby creating 4 temporary vacancies in the grade of SDE (E). At least two posts from these LA posts can be safely filled up by the administration to overcome the present problem and as well as to augment the requirement of SDE (E) for huge external works taken up by Odisha Civil wing.

Considering the fact that Odisha is a profit making Circle and Odisha electrical wing is carrying out all electromechanical services of all BTSs and major external projects started coming up two more SDEs (E) may be sanctioned for Odisha and arrangements may kindly be made to post them by modifying the current transfer order.
