- 3. The officer is required to join his promotion assignment within a time period of 40 [forty] days from the date of issue of this order. In case, the officer concerned failed to join his promotional assignment within the prescribed time period of 40 days, he should not be allowed to be relieved or join the post thereafter. In such an event, the promotion order shall become inoperative and the matter shall be reported to this office for further necessary action. Further, no request for the modification of promotion/posting orders shall be entertained after the expiry of the 40 [forty] days period.
- 4. On promotion, the pay will be fixed as contemplated in BSNL MSRR, communicated vide No.400-106/2007-Pers.I dated 14.07.2009.
- 5. The leave, if any, requested by the Executive, who is/are under transfer, should not be allowed. However, in case any Executive desire leave, he can apply for the leave to the Competent Authority only after joining the assigned place of posting and the respective Competent Authority will sanction leave, if it is considered justified, in the normal course.
