Subject: Absorption of Group 'A' officers including Indian Telecom Service (ITS) officers in Bharat Sanchar Nigam Limited (BSNL) and requirement of such officers in BSNL.

All Group 'A' officers including ITS officers working on deemed deputation in BSNL who have not opted for absorption in these organizations have been ordered to be repatriated to DoT vide BSNL Letter No 400-45/2013-Pers.I dated 11.03.2013, in compliance to DoT Office Memorandum No. A-11013/64/2012-Abs. Cell (I) dated 11th March 2013 issued by the Department of Telecommunications.

2. As per DoT order No. A-11013/64/2012-Abs. Cell (II-A) dated 11th March 2013, all the ITS officers as per Annexure 'A' repatriated from BSNL to DoT through the above-said repatriation order dated 11.03.2013 are hereby deployed in BSNL with effect from 11.03.2013 (A/N) as per terms and conditions of deployment of ITS officers in BSNL mentioned in DoT letter No. A-11013/64/2012-Abs.
