**Subject: Indifferent and harassing attitude of Rajasthan Circle administration towards the executives resulting sad demise of Com Ajay Tandon, AGM (CDR), Rajasthan Telecom Circle, Jaipur – reg.**

**Respected Sir,**

It has been brought to the notice of CHQ that members of AIBSNLEA Rajasthan Circle have expressed their serious resentment against the indifferent and harassing attitude of Rajasthan Telecom Circle administration towards the executives wherein Com. Ajay Tandon, AGM (CDR), Circle Office, Rajasthan Circle, Jaipur has become the victim of this harassing. Copy of the letter received from the Circle Secretary, AIBSNLEA Rajasthan is enclosed herewith for ready reference.

Due to his frequent transfers and regular harassment by senior officers after relieving for immediate joining to posting place, he was under severe stress since the issuance of the orders and due to non-consideration of his request to circle administration for cancellation of the said transfer orders which Rajasthan Telecom Circle administration did not listen and due to this persistent stress, he expired in office on 23.03.2015 (Monday) with severe heart attack.

Com. Ajay Tandon, AGM (CDR) - 1979 JTO batch was an outstanding executive of BSNL. He worked in BSNL CO EB Cell also for three years and got outstanding CR entries.

CS, AIBSNLEA Rajasthan Circle continuously requested CGMT Rajasthan for cancellation of the undue pick and choose transfer of Shri Ajay Tandon, AGM but he did not consider the request for the reasons best known to him.

It is reliably learnt that on 23.03.2015 at 11.45 Hrs CGMT Rajasthan Circle called Shri Tandon in his chamber in the presence of GM (HR & Admn), GM (IT) and DGM (OFC), Circle Office, Jaipur. On this time and after that GM (IT) again called Shri Tandon and pressurized him to join the new posting office. Thereafter, at 01.30 hrs Shri Ajay Tandon due to the extreme stress met with heart attack in PGMTD Jaipur premises which needs to be investigated through an independent agency.

On 26.03.2015, an emergency meeting of AIBSNLEA Circle Office Bearers and District Secretaries / Presidents stationed at Jaipur was called, wherein all were opined that the role of Circle Administration is suspected in the case and also showed strong resentment for them. AIBSNLEA, Rajasthan has demanded that the whole issue be investigated within a time bound manner by a transparent agency and accordingly action should be taken against the officials/officers involved in this issue.

AIBSNLEA's Rajasthan Circle representatives has already met CGMT, Rajasthan Circle and appealed him to investigate the whole issue within a time bound manner by a transparent agency and accordingly to take action against the officials/officers involved in this issue.

But till date, no inquiry has been initiated. In view of the above, it is requested to kindly issue the immediate necessary instructions for investigation of the above said incidence within a time bound manner by the vigilance cell so that stern action is taken against the officials/officers involved in this case.
