Subject: Immediate implementation of transfer orders (including posting on promotion) in the grade of AGM/DE in Telecom Operation Stream-regarding

Sir,

A review of status of un-implemented orders in respect of officers in the grade of AGM/DE in Telecom Operation Stream has revealed that officers as per enclosed Annexure(s), are still to be released by their parent circle(s) inspite of the instructions on the subject issued from BSNL Corporate Office from time to time, thus defeating the very purpose of transfer.

In view of the above, the Competent Authority has decided the following course of action:

- (a) The promotion orders to the grade of AGM/DE issued vide this office order No. 412-12/2013-Pers.I dated 19.07.2013, 23.07.2013, 26.07.2013, 7.08.2013 & 20.08.2013 in respect of Executives who have not joined their assigned posting on promotion, shall become **in-operative/cancelled** w.e.f. **01.08.2014 F/N**. As such, all promotion orders are to be implemented by 31.07.2014 A/N.
- (b) Executives transferred to other circles including tenure postings where they are incumbents of transferred officers having completed their prescribed tenure postings, are to be released **immediately** presuming no order is likely to be issued from BSNL CO, with regard to their retention/ modification etc., excluding cases covered under the orders of the Hon'ble Courts. On release of such officers, salary should not be drawn by parent circle(s) w.e.f. 01.08.2014.
- (c) Officers on expiry of their retention order, if any and/or the officers who are under transfer but not being reflected in the Annexure(s), are also to be treated alike para (b) above.
