On the subject cited above, it is reliably learnt BSNL, instead of implementing Hon'ble Apex Court directives about the seniority of absorbed TES Group "B" officers, has preferred to refer the case to DoT.


In this context, your kind attention is drawn towards DoT letter number 20-14/2007-STG-II dated 06.09.2018 wherein with the approval of Secretary (Telecom), it is clearly mentioned that the absorption of TES Group "B" officers in MTNL / BSNL has attained finality. However, the matters related to seniority / court cases in respect of these absorbed employees are still being handled by Establishment Division of DoT. **It has decided that all the matters pertaining to these absorbed TES Group "B" employees will henceforth be dealt by respective PSU only and not by DOT.** All the records pertaining to seniority / court cases in respect of these absorbed employees are being transferred to the respective PSU. Copy of the letter is attached herewith for ready reference.

In view of these guidelines, the matter of seniority of TES Group "B" officer should not have been referred to DoT as now the DoT has nothing to do with the seniority of absorbed TES Group "B" officers.

We, therefore, humbly request your kind honour to implement the Hon'ble Apex Court directives about the seniority of absorbed TES Group "B" officers immediately without further delay instead of referring the case to DoT.
