Dear comrades,



In other words, the Board of Directors meeting is going to give approval to the appointment of Shri Amit Yadav, IAS, as the CMD of the Subsidiary Tower Company.




In view of the foregoing, we earnestly urge upon you to roll back the Subsidiary Tower Company.


