




**Sub: Depositing of 60% of arrears of pay.**

Ministry of Finance vide their letter No. F.No.1/1/2008-IC dated 25.08.2009 has issued instructions for payment of second installment of arrears on account of implementation of Sixth Central Pay Commission's recommendations while incorporating the provision for deposition of arrears in GPF Account on voluntary basis also. This has been circulated by DOT vide No. 1-5(1)/2008-PAT dated 28.08.2009.

This office has been receiving requests in this regard from officers, i.e i) who are working in BSNL on deemed deputation basis ii) who have worked in BSNL but now working in Govt (DOT/TRAI etc) and iii) absorbed in BSNL but subscribing to GPF, for depositing the entire 60% arrears of pay to GPF.

BSNL is of the view that above order is also applicable to the employees working in BSNL and subscribing to GPF in respect of all the three categories of officers mentioned above.

You are therefore requested to confirm the above interpretation of BSNL so that they can be allowed to deposit the arrears of pay in GPF voluntarily.
