**Sub: Whimsical transfer of Shri N. Sundara Raman, DDG (CMTS) Corporate Office to Bihar Telecom Circle- Our protest against.**

Sir,

In the above context, we strongly oppose the whimsical transfer order of Shri N. Sundara Raman, DDG (CMTS) Corporate Office to Bihar Telecom Circle. Shri N. Sundara Raman is one of the most dedicated & honest officer of BSNL, who has been closely associated in the developmental work of BSNL. Since his taking over the charge of DDG (CMTS), he successfully completed tendering work of GSM telephone lines planned by BSNL in targeted period. He is the officer who never came under pressure. The recent 45.4 million GSM lines tender (2G+3G) could also be completed by him in a transparent manner. Some disqualified bidders of this tender challenged their disqualification in the Court of Law, but could not prove the tendering process wrong & ultimately they withdrew the court case unconditionally. It is learnt that the disqualified bidder has complained to Hon'ble MOC & IT & in response to their complaint Hon'ble MOC has asked some clarification from BSNL Board in the matter. Moreover, the reply of Hon'ble MOC queries are being finalized by the BSNL Management, meanwhile officer concerned i.e. DDG(CMTS) Shri N. Sundara Raman has been whimsically transferred from Corporate office to Bihar Telecom Circle which is not justified. This whimsical transfer of dedicated & honest officer has demoralized & de-motivated the entire BSNL workers.

We would, therefore, request you to kindly intervene in the matter so that this unjust and whimsical transfer order is immediately cancelled & the frustration caused in the mind of BSNL employees is removed.
